## <Usage Conditions>

### **About "Online Hazard Map Hiroo":**

"Online Hazard Map Hiroo" (hereinafter referred to as "this site") is a website where users can view information about hazardous areas (tsunami disaster warning areas, landslide disaster warning areas, assumed flooding areas) within Hiroo Town, as well as designated emergency evacuation sites and designated shelters by a personal computer, smartphone, or other device.

Before using this site, please be sure to read and agree to the following usage conditions and terms of service. By using the data, it is assumed that you have agreed to the following usage conditions and terms of service.

## <Terms of Use>

### (Applicable Scope)

Article 1: These terms of use apply to all relationships concerning the use of "Online Hazard Map Hiroo" (hereinafter referred to as "this site") between the user and the Hiroo Town.

### (Prohibited Acts)

Article 2: In using this site, the user must not engage in the following acts:

- (1) Acts that violate laws or public order and morals.
- (2) Acts that destroy or interfere with the functions of the server or network related to this site.
- (3) Acts of using the provided information for profit-making purposes.
- (4) Any other acts that Hiroo Town deems inappropriate.

### (Copyrights and License)

Article 3: The copyrights to the data belong to Hiroo Town or third parties who have licensed the rights to Hiroo Town.

2. The background maps used on this site, except for some aerial photographs, are based on the Geospatial Information Authority of Japan's tile service, and their use is subject to the Geographical Survey Institute's terms of use.
3. Hiroo Town grants the following rights to users within the scope of private use defined by the Copyright Law. However, users shall not acquire any rights other than those explicitly licensed under these terms of use with respect to the data on this site.
